WHO G.1

Establishing boundaries for the development and use of mRNA vaccines

In WHO we got to witness an attempt at amendment by the Lebanese Republic. Part of the clause involved creating a minimum of 10 institutions. The delegate of Lebanon argued that the creation of 10 institutions was not financially viable for lower income countries like themselves and proposed a reduction of the value to a minimum of 1 institution. The delegation of Canada agreed with Lebanon, demonstrating its support for the amendment. However, the Democratic Republic of Congo, showed itself in disagreement with the amendment, stating that having only 1 institution per country would mean certain

citizens having to travel very far for a vaccine. Nevertheless, the amendment passed.

Ghana then made its second motion to move into voting procedure. The motion was seconded by multiple delegates. The vote ended with the clause not passing. Clapping was not in order.

In WHO G.2, we witnessed several arguments about the USA's clause. France showed itself in favour of the clause and an amendment was passed simply to clarify that the vaccines would be administered to those who chose to take them. Israel demonstrated concern about lower income countries not being able to afford mRNA vaccines but France refuted this point stating that many organisations

existed to help developing nations fund vaccination programs. Italy also spoke in favour of the clause stating that it was made up of 'particular and precise guidelines', and encouraged their fellow delegates to vote in favour of it.

The Democratic Republic of Congo then proposed a controversial amendment. One of the subclauses involved providing vaccines at a maximum price of \$10. Congo disagreed with this, requesting the wording to be changed to 'sold at a reasonable price depending on the vaccine and its cost of production research. amendment was strongly contested.

Italy pointed out that the original clause already provided for a range of prices and that the phrasing 'reasonable price' could easily be exploited by companies to profit more from the vaccines. Congo then argued that an insurance system could be relied on to cover part of the cost of the vaccines but Italy and France strongly disagreed with this idea, both stating that this would mean a drastic, impractical change to the healthcare systems of all member countries and lower income nations may not even be able to afford

Security Council Accountability for committed and ongoing War Crimes.

In Security Council, we witnessed a discussion hetween delegations of the United States and Malta the over complicated issue of witness protection. The United States worried that their argument for divulging information about war crimes would put the victims of these crimes at risk. Malta disagreed



arguing that there was no need to share information on victims. When the US argued that a lot of the time victims provide a large part of the evidence, Malta retorted that there are many ways of concealing their identities, such as voice changers.

Human Rights

Ensuring equitable women's rights and the right to abortion.

In Human Rights, the delegation of Korea stressed the importance of placing as much worth on psychological needs as we do on physical ones. The delegate of Luxembourg argued for women being allowed to work wherever they'd like, being able to make their own decisions about whether to take on dangerous jobs.

DISEC

Controlling the abuse of brute and unethical force by authorities.

When we arrived, debate in DISEC was centred around sub-clause c) of Oatar's clause. The subclause argued for mandatory moral education as a measure for reducing police brutality. France proposed an amendment to strike sub-clause c) because argued that it would allow



theocratic and authoritarian governments to abuse human rights.

Canada showed itself strongly in favour of this amendment, arguing that morality subjective and therefore it is pointless to try to impose an international code of morality. The delegation of Canada went on to argue that these topics should not and cannot

he discussed at international basis and should instead be agreed on on a national level. They also stated that the sub-clause could easily be abused by authoritarian governments as a means of indoctrinating its people.

PRC. The however. disagreed. They argued that police brutality is at least partially a cause of the lack strict, well-defined international moral code. The delegation of China declared that if countries were allowed to educated their citizens against an international moral code, police brutality would After a decrease. vote. France's amendment passed.



DISEC Committee Session I

ECOSOC

The issue of ensuring worldwide sustainability and the scaling down of negative environmental measures.

In ECOSOC, the discussion revolved around funding for a commission, CISS (Commission of Implementing Sustainable Solutions). When we arrived, the delegation of The Netherlands was busy telling their reasons on why they believe removing the sub-clause that stated "This organization will be funded by the ECOSOC Committee," was not a viable decision. The delegation of The Netherlands stated that preventing funding

from ECOSOC for CISS could lead to negative environmental concerns and this is an issue because "the world cannot handle any more environmental concerns."

The delegation of the United Kingdom then decided to propose a second degree amendment and changed the sub-clause say "This organization will be funded by, but not limited to, ECOSOC." The delegation of South Africa

was against the amendment and stated that ECOSOC is funded by all member states, which is the most efficient method. The delegation of South Africa then asked a follow up question which was, "Which organizations the delegation of the United Kingdom believes would be suitable to fund CISS?" The delegation of the United Kingdom then said that any organization that is willing to would be welcome to fund CISS.

The delegation of The USA was for the second degree amendment, stating that extending funding allows each country to have its own funders."

The delegation of Angola was also in favor of the second degree

amendment, stating that CISS is not the only project ECOSOC funds, limiting the amount of money ECOSOC can towards CISS.

The second degree amendment ended up passing and the amendment to remove the sub-clause as a whole did not pass. Once again, clapping was not in order.

Professora Leta Ferreira

Despite her many responsibilities and the tiring nature of her job, Professora Leta Ferreira agreed to my interview immediately and with a smile. She talked to me about her favourite part of being an MUN director, stating that she loved watching her students grow as they started by slowly developing an interest in the club, to asking for more and more opportunities at participation, to eventually requesting to organise a conference themselves. Despite this being her first MUN conference Ms Rigato, a teacher at Colégio São João de Brito, cheerfully explained that she is excited to be here and learn from the experience.

When asked what she believes the benefits of participating in an MUN conference for students is Ms Rigato said that there are many benefits, "One of them is "Having the chance to talk address and talk about issues that are discussed [at MUN] that are very important

and to broaden up their perspective of the world."

Ms Rigato went on, saying that it enables students to "wake up their curiosity" about life, especially beyond their everyday life.
